DRR's current mini lineup features 50cc, 70cc and 90cc ATVs. All three of these minis can be sold today. Despite a CPSC ruling that has the major manufacturers discontinuing the sale of their youth 50cc-70cc minis for riders under 12, DRR has happy customers leaving with product in hand.

The CPSC has very specific safety tests for each age range of products which went into effect on February 10, 2009. The test includes a specific-sized probe to determine if young children's fingers can access questionable components. To make sure DRR was in compliance early, they took advantage of scheduled CPSC meetings over the last three years where any manufacture could learn about what will be tested and how the tests would be performed.

DRR's biggest competitor was completely unaware of the changes, as were many ATV companies.

DRR's front man, Louis DeCuzzi, says, "The CPSC employees have been very cordial and answered questions from our company. Unfortunately, it did take over six months for an e-mail response and phone calls from me to get answered. Our goal has always been to create a safe quad for the youth market and make it with more features than all the others for the same price.
